HOW TO APPLY –

OLD BEACH ART MARKET IS A JURIED SHOW. Print this application, complete and mail with your one time \$10 non-refundable application fee and three photos of your art to: Old Beach Art Market, 600 22nd Street, Suite 102, Virginia Beach, VA 23451. You may also apply by sending application/information to OldBeachArtMarket@hardysinc.com and mailing the application fee to above address. We will email your acceptance. Once accepted, you must pay in advance for each market you plan to join.

BUSINESS LICENSE – Each artist MUST have a City Business License specific to Old Beach Art Market’s location. Our liaison in the Virginia Beach Commissioner of the Revenue’s Office is Maggie Blynn. Maggie is happy to work with you by email. MBlynn@vbgov.com 757-385-6410

COST – \$ 15 per Saturday for a 10’ x 10’ space. Payment by exact change or check.

INSURANCE – Liability insurance is **STRONGLY SUGGESTED** but not required at this time.

STANDARDS – Displayed art must be suitable for a family audience. Artists must represent their original work. We do not require that artwork be framed. When two artists share a space, one must be on-site. Assistants are welcome but not to replace the artist. Each artist is responsible for collecting and remitting Virginia sales taxes.

SET UP AND TAKE DOWN – Set up begins one hour before opening – (Set up time to be announced; generally 8:00 a.m. for monthly markets and 7:00 a.m. for weekly markets.) **PLEASE ARRIVE 10 MINUTES BEFORE SET UP BEGINS. ALL VENDORS ARE REQUIRED TO HELP CLOSE 19TH STREET BEFORE SETTING UP THEIR OWN SPACE.**

MARKET MANAGER ASSIGNS SPACES. Find MARKET MANAGER Ashley Smith (Artist) or Christina Trapani of Old Beach Green Market for your location. If something comes up after 4:00 p.m. Friday and you won’t be with us, **PLEASE CALL Ashley – 642-5405 OR Christina – 613-5683.**

After being assigned your space, pull up to the curb by Croc’s and unload. You might be directed to park behind your tent at some markets. If not, **THEN** go park your car. You can use the Runnymede lots on Cypress between 20th and 21st. The lot behind WRV is for Old Beach Market customers.

No artist may leave before 12:00 p.m. Artists leaving earlier, except in emergency situations and with the approval of the Market Manager, will not be allowed to exhibit in future Old Beach Art Markets. All materials must be removed from the display area by 12:30 p.m. **ALL VENDORS ARE REQUIRED TO HELP RE-OPEN 19TH STREET AFTER PACKING UP THEIR OWN SPACE.**

Artists not following the rules **WILL NOT BE ALLOWED TO PARTICIPATE.**

Generally, a 10’ x 10’ tent is required. Artists must provide their own display materials. No utilities are provided. Furnish your space with (three-sided) weighted tents (no stakes), folding tables, beach chairs etc.

CANCELLATIONS – In the event of inclement weather, artists will be notified by phone and/or email. Up-to-date announcements will be posted on the Old Beach Art Market Facebook page. Use common sense – you’re not obligated to participate in bad weather.
