BUSINESS LICENSE – Each artist/vendor **MUST** have a City Business License specific to Old Beach Art and Eco Market’s location. COST – Each artist/vendor agrees to pay \$25 per Saturday for a 10’ x 10’ space. Payment by cash or check will be submitted to market manager at the beginning of each market. Checks should be made out to Old Beach Art and Eco Market. You may also pay via square but there will be a \$2 service charge:

STANDARDS –

Artists: Displayed art must be suitable for a family audience. Artists must represent their original work Artwork need not be framed.

Eco Friendly: Products must be reused, recycled, upcycled, reclaimed, found, sustainable alternatives and/or Fair Trade certified.

All Vendors: We are an eco-friendly event following Virginia Green guidelines. Please use/give plastic bags only if necessary. **Prohibited items: Balloons, Glitter, Harvested Animals (starfish, shells, seahorses, etc.), Polystyrene packaging**

SALES TAX – Each artist is responsible for collecting and remitting Virginia sales taxes.

SET UP AND TAKE DOWN – Set up begins 7:45 a.m. We ask that you arrive no later than 8:15 so all spaces can be assigned and set-up can begin.

MARKET MANAGER ASSIGNS SPACES. Find MARKET MANAGER Christina Trapani for your location. Add Christina (613-5683) to your contacts list so if something comes up after 4:00 p.m. Friday and you won’t be with us, you can let us know by calling or texting (preferred) Christina. Two “no shows” will disqualify you for the remainder of the season.

If you your space is in the south side of the park, unload at the curb on 18th Street (do not park on the crosswalk). THEN go park your car. If your space is in the north side of the park, unload from Wareing’s lot. Please unload your car and go park before setting up. Use the Virginia Beach Public Library parking lot. Park AWAY from the building, preferably on the south side of the lot adjoining 17th Street.

DO NOT PARK IN THE WAREING’S GYM PARKING LOT.

SAVE PARKING ON 18TH STREET FOR OUR CUSTOMERS.

No artist/vendor may leave before 12:00 p.m. Artists/vendors leaving earlier, except in emergency situations and with the approval of the Market Manager, will be disqualified to exhibit in any remaining 2020 Old Beach Art and Eco Markets. All materials must generally be removed from the display area by 1:00 p.m. ALL VENDORS ARE REQUIRED TO HELP RETURN THE AREA TO PRE-MARKET CONDITION AFTER PACKING UP THEIR OWN SPACE. Trash barrels are limited – please take your trash with you.

A 10’ x 10’ tent with weights is required. Artists/vendors must provide their own display materials. No utilities are provided. Furnish your space with weighted tents, folding tables, beach chairs etc.

CANCELLATIONS – We are a rain or shine event. However, in the event of a Friday decision to cancel because of inclement weather, artists will be notified by phone and/or email. Up-to-date announcements will be posted on the Old Beach Art & Eco Market Facebook page. Use common sense – you’re not obligated to participate in bad weather. JUST KEEP US INFORMED.
